

Documents required for the application for acceptance as a Doctoral Candidate

IMPORTANT: Applications need to be submitted no later than 14 days prior to the meeting of the doctoral admission committee. Applications can only be processed if documents are complete.

- 1.) application for acceptance as a doctoral candidate
the **application form** can be downloaded after registering as a potential doctoral candidate at the [Karlsruhe House of Young Scientists](#). Please submit the signed original.
- 2.) Bachelor's and Master's Certificate (certificate + transcript of records, no originals needed, copies are ok)
If your degree has been awarded by a non-German institution: please provide copies of your Master's and Bachelor's degree (certificate + transcript of records + information on the grading system, both in the original language and English translation) as well as your CV by email 2 weeks prior to the meeting of the doctoral committee
- 3.) justified request in written if your degree was obtained in a field other than civil engineering, geosciences or environmental sciences
- 4.) Curriculum vitae
- 5.) a declaration in writing according to Annex 5a of the Doctoral Regulations*
Find a template for this declaration on the next page and an English translation on the following page.
Please note that the German form needs to be used exclusively. The English translation is to be understood as a service for your information. Please submit the signed original.
- 6.) a copy of the doctoral agreement (information is to be found at KHYS)
- 7.) your proposal for another 3 persons, who are authorized to award the doctorate, as members of your doctoral committee
For each person please provide: name, title, institution and email address
- 8.) your PhD certificate in case you have already been awarded a PhD from another institution
